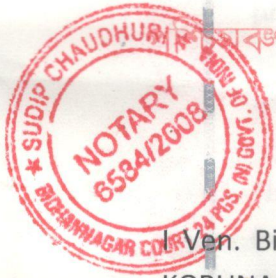
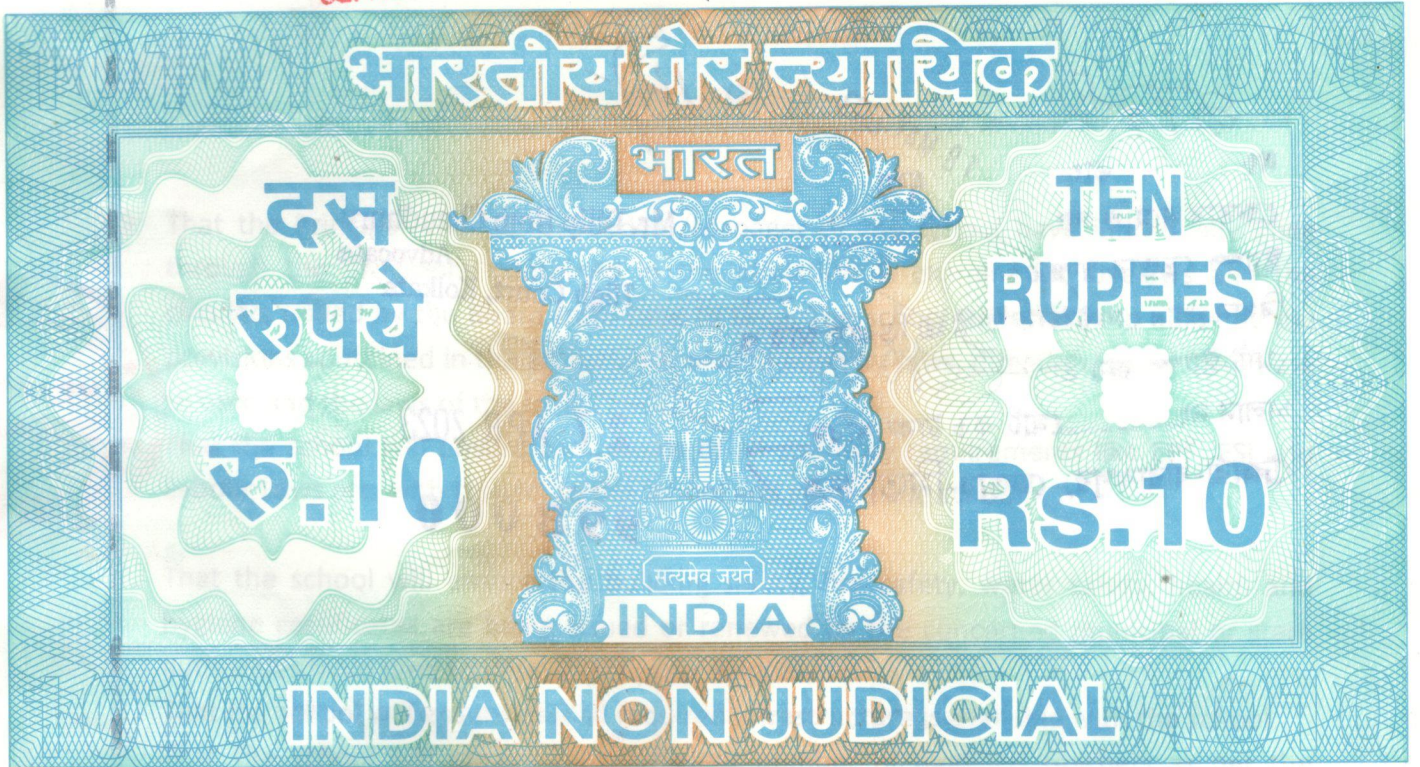

5. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination by-laws, direction issued from time to time and the laws of the land.

9. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bylaws are available with the school.


